

 - Julie Monnot 3 years in current position
 - Plus 11 other excellent outreach employees
 - In Tulsa all stormwater employees are involved in public outreach





Hire people that love their job

- Not just employees that want to put in their 40 hours and go home or people that say what do we have to do but people that say what can we do



WARNING

Successful education top-down or bottom-up?

- EPA/DEQ education requirements easily met
- These requirements alone honestly won't have much impact
- Education program needs to be driven from the bottom-up by the permittee
 - Example Requirement "Participate in public events (2 x per year) targeting litter reduction, include informative displays"
 - Example Requirement "Conduct events that promote LID to developers/contractors"




Broaden the Base





Video of Circle of streams commercial





What media is the best bang for your buck?


- Hard to say


How to gauge whether education program is working???

- Simplest way is if your streams are meeting all beneficial uses...it is working
- Surveys
 - Home and Garden Show: 36,000 people
 - Tulsa State Fair: 1.1 million people
 - Ask the same questions over and over
 - What is a watershed?
 - Where do stormdrains go?
 - Is Tulsa mandated to reduce pollutants in stormwater?
 - Use results to guide education program and gauge your success



My WATERS Mapper

MyWATERS Mapper dynamically displays snapshots of EPA Office of Water program data. This version of MyWATERS Mapper depicts the status of NPDES permits for each State; summary information from the Clean Watershed Needs Survey; and water guality assessments. Future versions will include other Office of Water Program Snapshots. MyWATERS Mapper also contains water-related geographic themes such as 12-digit watersheds, the national stream network known as the National Hydrography Dataset, and other water-related map layers. MyWATERS Mapper enables you to create customized maps at national and local scales.






Future To Do's
