## 18th Annual OCLWA Call for Posters

As part of the 18<sup>th</sup> Annual OCLWA Conference, undergraduate students from accredited colleges and universities are invited to participate in the *Fifth Annual Dale Toetz Student Poster Competition*. Students are invited to submit high quality poster presentations related to contemporary lake and watershed management issues. Poster prizes (including cash awards) will be given based upon study quality, individual contribution to the work, significance to lake and/or watershed management issues, and presentation clarity.

The poster should include the following: title (including authors and addresses), abstract, introduction, purpose, results, conclusion, and discussion. Lettering should be large and legible. The overall poster size should not exceed 48" X 48". Authors must supply a sufficient backing so the poster will stand upright on a table or easel. Posters will be displayed throughout the meeting. Competitors will be required to stand by their posters during the judging period (time to be announced in the Meeting Program).
